

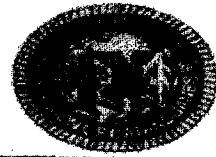



The *Pambansang Samahan Para Sa Edukasyon sa Pagpapahalaga* (PSEP) will be holding the 27th Annual National Convention and Seminar-Workshop on *Edukasyon sa Pagpapakatao* on December 2 to 5, 2017 at the Crown Legacy Hotel, Baguio City on December 2 to 5, 2017 per DepEd Advisory No. 268, s. 2017.
