

LIFTING THE SUSPENSION OF CLASSES IN ALL LEVELS IN THE PROVINCE OF CATANDUANES

WHEREAS, Section 16 of the Local Government Code of 1991 provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Executive Order No. 51, s. 2020, was implemented in the aftermath of Super Typhoon Rolly, which on Nov. 1, 2020, destroyed a majority of the Province of Catanduanes' infrastructure, power grid, communications, and industries;

WHEREAS, the same Order dictates the suspension of classes in all levels due to the extensive damage to school buildings and unstable or non-existent power supply;

WHEREAS, the Province has slowly recovered, with the restoration of road access, power, communications, and repair of facilities in some areas, allowing for the resumption of module reproduction and distribution;

WHEREAS, such recovery is substantial to warrant the resumption of classes in the Province;

NOW, THEREFORE, I, JOSEPH C. CUA, by virtue of the powers vested in me by law, do hereby lift the suspension of classes in all levels in the Province of Catanduanes, effective **Monday, January 11, 2021**.
