- 1. In support of the goal of sustaining delivery of quality and accessible, relevant and liberating education services for all diverse learners in the midst of COVID-19 emergency, the Department of Education issued DepEd Order No. 21 s. 2020, Policy Guidelines on the Adoption of the K to 12 Transition Curriculum Framework for Learners with Disabilities (LWDs), which articulates the principles, features and standards that will establish common understanding on the transition of LWDs in all private and public schools nationwide,
- 2.
