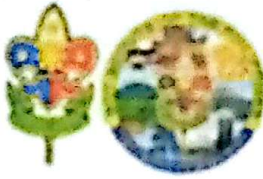



Subject : **2025 BICOL REGIONAL SCOUTS YOUTH FORUM**


Reference : 2025 BR Calendar of Scouting Events and Observances

1. We are pleased to announce the conduct of the **2025 Bicol Regional Scouts Youth Forum** to be held at **Bicol Regional Science High School, Tuburan, Ligao City** hosted by the Ligao City Associate and the Mayon (Albay) Councils on **07 - 09 February 2025**.
2. **Participants.** Qualified participants are Senior Scouts who are:
 - 2.1 currently registered with the BSP;
 - 2.2 **at least 14 years old but below 17 years old by December of the Forum Year 2025.**
 - 2.3 holders of at least the **Outdoorsman Badge**, and
 - 2.4 elected during the 2025 Council Scout Youth Forum.
3. **Activity Fee.** The Forum and **Billeting Fees of the Six (6) Council Official Delegates, two (2) Observers and two (2) Accompanying Adults** will be partially sponsored by one of the host Councils, the Ligao City Associate Council. Therefore, a Forum fee of One Thousand Pesos (PHP1,000.00), - one half (1/2) of the forum budget - shall be collected from all participants to cover costs of the souvenir T-shirt, handouts, certificate, Program and Administrative needs. The excess out of the Ten (10) identified participants (**Council Quota**) shall pay the full amount of Two Thousand Pesos (PHP 2,000.00).
4. **Quota per Council.** Each Council is entitled to a Maximum of six (6) official delegates, two (2) observers accompanied by two (2) registered Adult Leaders/Outfit Advisors, a total of ten (10) council delegates.
5. **Reporting Date.** The Members of the 2025 RSYF Organizing Committee and participants are expected to be at the venue in the afternoon of 06 February 2025 ready for the roll call. The Organization, Orientation and other Preliminary Forum activities will be held on the said afternoon.
6. **Attire.** Scout Participants must wear their type 'A' Scout uniform during the entire forum period.

7. CSEs/OICs are therefore advised to submit to the Regional Office the list of their official delegates, observers and accompanying adults for the preparation of the materials and other necessities on or before 31 January 2025.
8. This year's **Forum Adviser** will be **Sctr. John Paulo M. Doria** and the **Forum Coordinators** are **OIC Mark Anthony D. Dela Torre** and **ICO Arhjay Q. Alperaz**.
9. Expenses which maybe incurred relative to this event can be charged against local funds/MOUE/SEF subject to the usual accounting and auditing procedures, rules and regulations. Moreover, this memorandum will serve as your travel order.
