- 4. If the school has no donations received within the reporting month, it is expected that the school head shall submit a **Certification of No Donations Received** to this Office thru the SGOD-Social Mobilization and Networking Unit **on or before the last day of the reporting month.**
- 5. School Heads need to submit the hard copy of the Transmittal Report to the District Office thru the designated District Partnerships Focal Person and he/she shall then forward it to this Office thru the SGOD-SocMobNet Unit, after the DPDS report for the month has been uploaded.
