SUBJECT:

ORIENTATION-WORKSHOP ON THE ENHANCED QUALITY ASSURANCE WORKFLOW

1. In support to DepEd Memorandum No. 82 s. 2017, RE: Learning Resource Management and Development System in the Rationalized Structure, the Division Office through the LRMDS unit, will conduct one day Orientation -Workshop on the Enhanced Quality Assurance Workflow on July 24, 2018 for Batch 1 and August 17, 2018 for Batch 2 at the venue to be announced later.

2. The objectives of the training workshop are the following;

a. Orient and capacitate Quality Assurance Teams the processes of evaluating contextualized supplementary learning resources.

b. Evaluate supplementary learning materials for uploading and cataloguing in the LR Portal.

c. Discuss issues and concerns on the Quality Assurance of learning resources.

- 3. The expected participants for Batch 1 are 3 from each of the following schools composed of the School Head, LRMDS Coordinator and a Key Teacher or Master Teacher. Batch 2 will be composed of Public School District Supervisors and Education Program Supervisors of the different learning areas/programs They should be registered in the LR Portal with DepEd accounts before attending the orientation-workshop and are expected to be at the venue at 7:30 and stay up to 5:00 pm to maximize the 1 day activity.
- 4. All participants are requested to bring the following:
 - a. Laptop
 - b. Wifi device and extension wire
 - c. School/teacher -developed supplementary LRs for quality assurance/evaluation (minimum of 1 and maximum of 3 SLRs per school)
- 5. Participants are also expected to cascade the workshop to their respective municipalities after a series of quality assurance of their school supplementary learning resources which are to be further quality assured by Batch 2 participants or for second level evaluation and uploading to LR Portal.
- 6. Accommodation including lunch and 2 snacks shall be charged to HRTD fund while registration of Php 40.00 per participant from elementary and secondary schools shall be collected. The registration, travel and other incidental expenses of school participants shall be charged against school MOOE /local funds subject to usual accounting and auditing procedure. The registration shall cover handouts and other training materials. Travel expenses of PSDSs and EPSs shall be charged against Division MOOE subject to usual accounting and auditing rules and regulations.
