- 1. Pursuant to DepEd Order No. 72, s. 2003, Establishing of Youth for Environment in Schools Organization as the only recognized co-curricular environmental club / organization in the schools and consolidated all other environmental and/ or ecology clubs in the school with primary programs or projects for the environment, DepEd Order No. 93, s. 2011 entitled Mandated Programs, Projects and Activities Various Forms and Targets Pertinent to the Youth for Environment in Schools Organization and Republic Act (RA) No.9512 which promotes environmental education and addresses environmental concerns, SDO Catanduanes through the Science Club Advisers Association Of Catanduanes (SCAAC), will conduct the 2024 Division YES-O Camp for secondary, at Bagasbas, Brgy. Yocti, San Andres, Catanduanes on April 12-14, 2024.
- 2. This year's YES-O Camp Theme: "Advancing Nature and Promote Solutions for Net Zero Pollutants and Sustainable Future"
- 3. The general objectives of the YES-O Camp are:
  - a. To instill environmental values and skills in every student participant.
  - b. To develop higher order thinking skills (HOTS) through various activities in the camp.

- c. To encourage cooperation and collaboration in implementing activities for protecting the environment in the beautiful island of Catanduanes.
- The 2024 YES-O Camp activities shall include the following:
  - a. Panel Discussions
  - b. Plenary Sessions
  - c. Thematic Learning Sessions
  - d. Zumba dance contest
  - e. poster making
  - f. Sayawit
  - g. Clean-up Drive
- 5. The YES-O Camp is open to secondary learners. Considering that the activity will be conducted outdoor, a written permit must be secured from the parents indicating consent of the child's participation in the Camp. The Parent's Consent should be collected by the school YES-O Adviser and be submitted to the division committee on registration and attendance upon arrival in the camp on April 12, 2024
- 6. learners must be accompanied and duly supervised by their school adviser. All participants must bring their own tent and own beddings.
- 7. A registration of One Thousand Five Hundred Pesos (P1, 500.00) will be charged per participant to cover expenses for the tokens for the speakers and facilitators, guests' meals, supplies and other incidental expenses.
- 8. Expenses in this activity may be charged against the School MOOE, YES-O Funds and/or SEF, whichever is applicable.
- 8. For facilitation preparation for the Camp, participants are required to **PRE-REGISTRATION** through the YES-O advisers of the schools. Payment of registration fees must be made on or before **March 22**, **2024**, to the Division Cash Section c/o Ms. Liza R. Bernardo.
- 9. Participants are expected to be at the venue on April 12, 2024, before 1PM for the pitching of tent. The opening program will be at 3:00PM. School YES-O advisers shall take charge of their delegation's lot assignment for the pitching of tent.
- 10. Considering that April 13, and 14, 2024 fall on Saturday and Sunday, all teacher-participants are entitled to a two-day vacation service credit, in congruence to the

On the other hand, the non-teaching personnel are entitled to receive a Compensatory Overtime Credit (COC) for the accrued number of hours rendered on the same dates, as provided in CSC & DBM Joint Circular No. 2, S. 2004, re: Non-Monetary Renumeration for Overtime Service Rendered.
