

implement other forms of exercises based on needs assessment, aside from evacuation drills, to scale up overall earthquake preparedness. Further, coordination with local government units (LGUs) and community stakeholders, post-drill review, coordinated assessment, and evaluation shall be conducted. This is to ensure effective implementation of contingency plans and improve future preparedness efforts.

To increase awareness and enhance preparedness for the impending threat of the inevitable occurrence of an earthquake, even amid the pandemic, the Information, Education, and Communication (IEC) campaign in NSED using distant means should be continuously intensified. 
After each drill, the DRRM Teams must review and update their earthquake contingency plans, integrating new operational strategies and lessons learned to identify gaps.





### Guidelines on the Quarterly Submission of the 2025 Quarterly Nationwide Simultaneous Earthquake Drills (NSED) Report

All DepEd Regional Offices, Schools Division Offices, and schools should thoroughly follow the guidelines below:

#### I. Schools- Based NSED

#### For Schools

- 1. The School DRRM Coordinator shall accomplish the Monitoring and Reporting (M&R) Template (Annex B Template 1), to be signed by the School Head.
- 2. Guidelines on the photo and video documentation are in Annex C.
- 3. The signed form with attached photo and video documentation of NSED practices and initiatives shall be submitted to the respective Division DRRM Coordinators not later than five (5) working days, after the schedule of the quarterly NSED.

#### For Schools Division Offices

- The Division DRRM Coordinators must consolidate NSED reports and pictures from School DRRM Coordinators (Annex B - Template 3).
- 2. Consolidated NSED reports and pictures from schools must be submitted by the Division DRRM Coordinators to the DRRMS via email drrmo@deped.gov.ph not later than fifteen (15) working days, after the schedule of the quarterly NSED. Refer to the following table for the schedule of submission of the quarterly Division NSED report:



5. The cut-off time for all deadlines will be at 05:00 PM. The official number of schools participating in the NSED will be based on the consolidated NSED report signed by the Schools Division Superintendent (SDS) or authorized official from the division office to be submitted to DRRMS.

#### II. Office-Based NSED (Regional and Schools Division Offices)

- 1. All Regional Offices and Schools Division Offices are also enjoined to conduct quarterly NSED in their respective offices. The Regional/Division DRRM Coordinator shall accomplish the Monitoring and Reporting (M&R) Template (Annex B - Template 2), to be signed by the Regional Director/Schools Division Superintendent, respectively.
- 2. The Regional DRRM Coordinators must consolidate NSED reports and pictures from Schools Division Offices (Annex B - Template 4).
- 3. Consolidated NSED reports and pictures from the Division Offices must be submitted by the Regional DRRM Coordinators to the DRRMS via email drrmo@deped.gov.ph not later that fifteen (15) working days, after the schedule of the quarterly NSED. 

### Guidelines on the Photo and Video Documentation of Quarterly Nationwide Simultaneous Earthquake Drill


The following guidelines is set for the photo and video documentation of the quarterly conduct of NSED in schools and DepEd offices:

- Photo and video recordings of quarterly NSED conduct may be used in information and communication materials of the Department, as requested.
- All materials should display adherence to minimum health protocols such as but not limited to, social distancing and wearing of face masks.
- 3. The following scenarios must be included in the documentation of the school:
  - a. Learners, personnel, and/or parents/guardians wearing personal protective equipment such as hard hats.
  - b. Learners, personnel, and/or parents/guardians doing the Duck, Cover, and Hold.
  - c. Conduct of coordination/preparatory meeting.
  - d. Actual conduct of the quarterly NSED.
- 4. The recommended minimum specifications are as follows:
  - a. Photo
    - i. File format: JPG or PNG
    - ii. Dimensions: 4:3 ratio or 16:9 ratio
    - iii. Orientation: Landscape
  - b. · Video
    - i. File format: MP4 or MOV (with 1080p or 720p resolution)
    - ii. Dimensions: 1920px x 1080px (16:9)
    - iii. Orientation: Landscape
    - iv. Frame rate: 30fps or 60fps

The Philippines, situated along the seismically active Pacific Ring of Fire, is susceptible to frequent earthquakes and volcanic eruptions. Recognizing this, the National Disaster Risk Reduction and Management Council (NDRRMC), guided by Republic Act (RA) 10121, has implemented various measures to mitigate earthquake risks and other geological hazards. These measures encompass contingency planning, incident Command System training for effective response, organization of Response Clusters, intensified public awareness campaigns, and strengthened inter-agency coordination.

A cornerstone of the NDRRMC's initiatives is the Nationwide Simultaneous Earthquake Drill (NSED), conducted quarterly under the leadership of the Office of Civil Defense (OCD). NSED aims to assess the nation's capacity to respond to earthquakes, particularly in ensuring public safety through well-organized evacuation and response procedures.

In view thereof, the schedule for the CY 2025 Quarterly Nationwide Simultaneous Earthquake Drill (NSED) is hereby disseminated:



### PROMOTING FAMILY EARTHQUAKE PREPAREDNESS

To: Regional Directors Schools Division Superintendents Heads, Public and Private Elementary and Secondary Schools All Others Concerned

In conjunction with the National Disaster Consciousness Month observed annually every month of July, the Department of Education (DepEd) promotes Family Earthquake Preparedness to all elementary and secondary schools and instructs all schools to conduct the following activities as part of their respective overall preparedness plan:

all learners shall be required to accomplish the family earthquake preparedness homework [Enclosure 1 (Filipino) or Enclosure 3 (English) for K to G2 and SPED; Enclosure 2 (Filipino) or Enclosure 4 (English) for G3 to G10]

with their families and submit it to their respective class advisers;

all class advisers shall discuss each of the questions with the students along with their family's responses to the homework using the guidance notes (Enclosure 5) during the homeroom session;

all class advisers shall tabulate and summarize the answers on the family earthquake preparedness assessment questions and submit it to the school

administration; and

- all school heads shall present and discuss the results to the Parents-Teachers Association (PTA) and barangay officials for consideration in the school and community preparedness planning
- The Guidelines support DO No. 55, s. 2007 (Prioritizing the Mainstreaming of Disaster Risk Reduction and Management in the School System and Implementation of Programs and Projects Relative Therefor, and DO No 21, s. 2015 (Disaster Risk Reduction and Management Coordination and Information Management Protocol), which seek to engage different education stakeholders, especially learners and their families in disaster prevention and preparedness.

### GUIDANCE NOTES FAMILY EARTHQUAKE PREPAREDNESS HOMEWORK

### I. Preparing for the Distribution of Family Earthquake Preparedness Homework

- Before discussing the homework in class, all advisers shall review the attached reference materials on earthquake preparedness (Enclosure 6). This could also be downloaded from the website of Philippine Institute of Volcanology and Seismology (PHIVOLCS) <a href="http://www.phivolcs.dost.gov.ph/index.php?option=com\_phocadownload-wiew=file&id=71:earthquake-are-you-prepared&Itemid=44">http://www.phivolcs.dost.gov.ph/index.php?option=com\_phocadownload-wiew=file&id=71:earthquake-are-you-prepared&Itemid=44</a>;
- All advisers shall explain the homework to their students during homeroom and guidance session using the appropriate set of questionnaires based on the grade level and medium of instruction; and

# FARTHQUAKE!!!

## (Are you prepared?)

### BEFORE

#### The key to effective disaster prevention is planning:



- Know the earthquake hazards in your area.
- Follow structural design and engineering practices when constructing a house or building.
- Evaluate the structural soundness of the buildings and houses; strengthen or retrofit if necessary.

#### Prepare your homes, workplace or schools:

- Strap or bolt heavy furnitures cabinets to the walls.
- Check the stability of hanging objects like ceiling fans and chandeliers.
- Breakable items, harmful chemicals and flammable materials should be stored properly in the lowermost secured shelves.
- ✓ Always turn off the gas tanks when not in use.



Familiarize yourself with the exit routes and places where fire extinguishers, first aid kits, alarms, and communication facilities are located. Learn how to use them beforehand.

Prepare a handy emergency supply kit with first aid kit, canned food and can opener, water, clothing, blanket, battery-operated radio, flashlights and extra batteries.

Conduct and participate in regular earthquake drills.

Do you know that about 20 earthquakes are recorded daily in the Philippines? Most of these earthquakes however, are unfelt and can only be detected by an instrument called seismograph.

Earthquakes cannot be prevented, but we can prepare for them.

Always remember these basic things to do before, during and after a strong earthquake:

### DURING

#### STAY CALM.

### When you are INSIDE a structurally sound building or home...STAY THERE!

Do the "DUCK, COVER and HOLD".



- Duck under a sturdy desk or table, and hold on to it, or protect your head with your arms.
- Stay away from glass windows, shelves, cabinets and other heavy objects.
- Beware of falling objects. Be alert and keep your eyes open.

Provide access to children, pregnant, elderly and persons with disabilities during evacuation.



#### If you're OUTSIDE.. move to an open area!

- Stay away from trees, powerlines, posts and concrete structures.
- Move away from steep slopes which may be affected by landslides.
- If you're near the shore and feel
  an earthquake, especially if it's
  too strong, move quickly to higher
  grounds. Tsunamis (giant sea waves)
  might follow.

If you're in a moving vehicle, STOP and get out! Do not attempt to cross bridges, overpasses, or flyovers which may have been damaged.



### AFTER

#### Be prepared for aftershocks.

### Once the shaking stops, take the fastest and safest way out of the building

#### Don't ...

- ...use elevators.
- ...enter damaged buildings.
- ...use telephones unless necessary.
- ...PANIC.

#### Check ...

- yourself and others for injuries.
- water and electrical lines for damages.
- for spills of chemical, toxic and flammable materials.
- and control fires which may spread.

If you need to evacuate your residence, leave a message stating where you are going and bring your emergency supply kit.

Keep updated on disaster prevention instructions from battery-operated radios.
