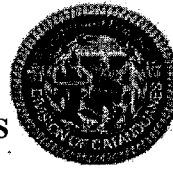

1. In compliance with the Regional Memorandum No. 70, s. 2016 Re: Regional Seminar Workshop on Pedagogy for ALIVE Implementers and in response to the call for quality delivery of the K to 12 Basic Education Curriculum and corollary to the mandates of inclusive education, this Division will hold a 3-day Seminar Workshop on Pedagogy and Orientation for Arabic Language and Islamic Values Education (ALIVE) Program Implementers at Schools Division Office Conference Hall-A on May 9-11, 2017.
2. Specifically, the objectives of this activity are:
 - a. Capacitate Asatidz on Lesson Planning and different methodologies and strategies in teaching ALIVE,

3. Expected participants are Asatidz, Selected School Heads, District ALS Coordinators, ALS Education Program Specialists, Public Schools District Supervisors, Division ALIVE Coordinator, Resource Speakers and Trainers during the training workshop.
4. Traveling expenses of School Heads, Asatidz shall be charged against School MOOE while PSDSs and District ALS Coordinators and Education Program Specialists shall be charged against local fund subject to the usual accounting and auditing rules and regulations.
