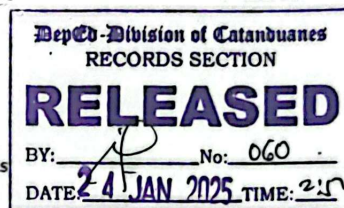

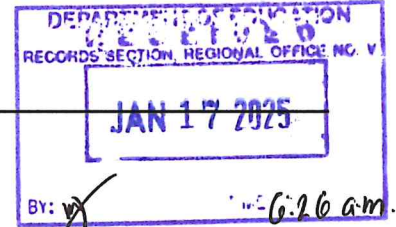

5. Assessment and Feedback (10%) <i>Clarity of Instructions:</i> Are tasks and activities clearly explained? <i>Assessment Methods:</i> Are there meaningful ways to evaluate learner understanding? <i>Constructive Feedback:</i> Is feedback provided to support learning and improvement?

3. A pre-recorded video of demo-teaching shall be submitted as the entry, teacher may choose to have it with **learners (make sure with parent's permission or consent)** or without learners.
3. The duration of the video should be within 30 minutes.
5. Each participant will be evaluated by resident evaluators, the different master teachers, school heads and head teachers from different SDO's.
6. The decisions of the evaluators are final, and irrevocable.
7. All demo teachers will receive the following:
 - an invitation letter address to their respective SDOs
 - Certificate of attendance
 - certificate of participation
 - certificate of evaluation indicated the scores obtained, signed by all evaluators
7. After the event, the panel of evaluators will choose the Outstanding Demo Teachers which will receive the following:
 - a. Certificate as outstanding demo teacher
 - b. Trophy
 - c. Medal
 - d. Evaluation sheet
 - e. certificate of corroboration
