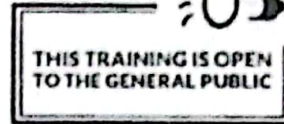

Effective February 25, 2025, the new Implementing Rules and Regulations of Republic Act No. 12009 or the New Government Procurement Act will impact on all government procurement transactions.
