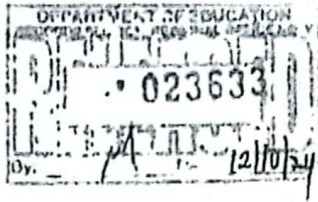

TEMPORARY WITHHOLDING OF GSIS MPL LITE APPROVAL

To : Schools Division Superintendents  
School Heads of Implementing Units and Fiscal Autonomous Schools  
All Others Concerned

1. This refers to the new loan product of GSIS called the MPL Lite.
2. This Office has not received yet official instructions regarding the deduction loan code. Though on the part of the GSIS, the latter already requested in writing to the DepEd Central Office for such issuance, until then, the billings submitted by GSIS indicating deductions for MPL Lite will not be accommodated in the Payroll System.
3. We recalled that we notified all AAOs regarding this matter through various platforms. Despite the same, some AAOs acted on the MPL Lite loan application, as shown below:

4. Based on the above data, the payroll in charge shall set aside temporarily the billings under MPL Lite. The AAOs shall hold in abeyance all MPL Lite loan applications until a specific loan deduction has been forwarded to this Office through the Payroll Services.

5. In addition, for those who were granted MPL Lite loans, the ERF Handlers in coordination with the concerned GSIS Branch, must identify those MPL Lite borrowers and encourage them to pay using the over-the-counter mode through the SDUs to avoid delay in the remittance process.
