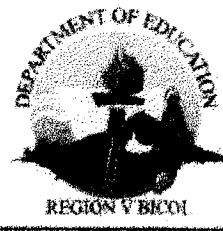
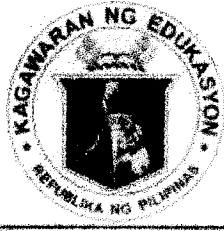

To strengthen and nurture the culture of research among DepEd Region V personnel, the Bicol Association of Schools Superintendents (BASS), in cooperation with DepEd Regional Office V, will hold the Fourth DepEd-Bicol Research Conference with the theme *Braving the 21st Century Challenges of K to 12 through Educational Research* on January 21-23, 2016 at the Villa Caceres Hotel, Naga City.
