Provincial Orientation Conference on the Administration of 2014-2015 National Achievement Test (NAT) and Language Assessment for Primary Grade (LAPG)

To: OIC Chiefs of CID and SGOD

Education Program Supervisors (EPS's)
Public Schools District Supervisors (PSDS's)
Heads, Public and Private Elementary and Secondary Schools
All Others Concerned

1. In consonance with DepEd Memorandum No. 127, s. 2014, the Department of Education (DepEd) through the National Education Testing and Research Center (NETRC) shall administer the National Achievement Test (NAT) and Language Assessment for Primary Grades (LAPG) nationwide as contained in the enclosure of DepEd Order No. 19, s. 2014- 2015, on the following dates:

March 5, 2015- fourth year High School Students of Public and Private Schools (Census)

March 11, 2015- Grade 3 pupils of Public Schools only (Census) March 12, 2015- Grade 6 pupils of Public and Private Schools (Census)

- 2. Only private elementary and secondary schools with permit to operate from DepEd shall be included in the conduct of the test.
- 3. Each Grade 6 NAT examinee shall be issued a Certificate of Rating (COR) containing the actual rating per subject area. The COR will reflect the examinee's readiness for Junior High School.
- 4. Instead of NAT (Grade 3) Language Assessment for Primary Grades (LAPG) shall be administered to all Grade 3 pupils in the public schools.
- Orientation Conference on the NAT and LAPG Standardized Administration on **February 23, 2015** at the DepEd Division Conference Hall C, Virac, Catanduanes. Elementary group shall report at 8:00- 12:00 in the morning while the secondary school heads at 1:00-5:00 in the afternoon.
- 6. Authorized to attend this Orientation Conference are the OIC Chiefs, EPS's, PSDS's and heads of every elementary and secondary school. All schools shall be represented by the head or by the School Testing Coordinator.

- 7. Updated number of enrollment of every school shall be submitted on or before the orientation date in a short bond paper for the allocation of the number of examiners.
- 8. Travel and other allowable expenses in attending this orientation are chargeable against local/ school MOOE, or other funds, subject to the usual accounting and auditing procedures. Snacks/ meals shall not be served.
- 9. Immediate dissemination of and strict compliance to this memorandum is desired.
