2015 DIVISION WELLNESS CAMPUS CONTEST

TO: Secondary School Heads
MAPEH Teachers

The 2015 Wellness Campus Program is a joint project of the Department of Education (DepEd) and Nestle Philippines Inc. (NPI), through Greatfill Team Inc. (GTI). This program not only aims to continue develop the wellness mindset among high school students through habit formation but is also encouraging the school to deliver its potential in terms of best performance and program execution and to provide a venue for the students to showcase and express their talents and gain self-confidence in the process through exposure.

In line with this program, the Division will conduct a 2015 Division Wellness Campus Contest. The participating school shall strictly comply with the following mechanics:

- 1. The contest is open to all interested secondary schools who have implemented the Wellness Campus Dancercise during the flag raising ceremonies, and the nutrition modules in their P.E. and Health classes. The implementation of the said program must include the whole school population which must be properly documented. The MAPEH Division Supervisor together with the GTI representative will validate the implementation before the school can be considered officially qualified to join the contest.
- 2. Submission of entry for the Division level will be in the form of a video presentation (video CD) that include the following:
 - a) Documented implementation of the Dancercise of the school and the nutrition module in their MAPEH classes; and
 - b) Performance of the Fifty (50) students of the Wellness Dancercise.

The CD shall be submitted to Mr. Nelson T. Sicio, EPS-1, MAPEH. Deadline of submission is on September 11, 2015. No entry shall be accepted beyond this date.

3. The Division winner shall be selected based on how the program was being implemented in the school and based on the performance of the best fifty (50) students who will dance their own interpretation of the Wellness Dancercise using the original version of the new Wellness Song. The school's own dance interpretation must keep the dance movements in the chorus portion of the Wellness Song intact.

4. A Division Evaluation Committee shall be created to select the winning entry based on the following criteria:

A) Quality of program implementation in scl	hool	-	50%
B) Performance during the Division showdo	own	nek	50%
a) Own interpretation (shows the theme on the			100%
importance of breakfast)	- 25%		
b) Synchronization of movements	- 25%		
c) Creativity (Props, Formation, etc.)	- 25%		
d) Showmanship	- 25%		

- 5. There will be one winner in the Division who will receive a cash prize of Twenty Thousand Pesos (Php 20,000.00, c/o by the Greatfil Team Inc.)) as support to the school's Health and Wellness Program. A Team from NPI and/or the Greatfill Team, Inc. will visit the winning school to witness their actual performance, check on the nutrition module implementation and €award the prize. The winner will represent the Division to the 2015 Regional Wellness Campus Showdown on September 30, 2015. The venue will just be announced later.
- 6. Any decision of the judges, with respect of the conduct of the contest, the selection of winners and other matters related to the contest shall be final and not subject to appeal.
- 7. Wide dissemination and immediate compliance of this Memorandum is hereby desired.
