

DepEd-Regional Office No. V remains committed to the continuous provision of learning opportunities for Bicolano learners amidst the public health emergency currently experienced due to COVID-19. This necessitates, among others, the implementation of modified enrollment process that adheres to the guidelines set by the Inter-Agency Task Force on Emerging Infectious Diseases ((IATF-EID), the Office of the President and the Department of Health. This is embedded in DepEd Order No. 008, s. 2020, re: Guidelines on Enrollment for School Year 2020-2021 in the Context of the Public Health Emergency due to COVID-19. The same guidelines should also be adhered to in the enrollment of learners in the Special Programs in Journalism and Foreign Language.

Learners' admission to these two special programs shall be modified this School Year 2020-2021, in terms of the conduct of the qualifying examination and interview, considering that making physical appearance in school for such activities shall be the last option, and only when it will be allowed by the health authorities and LGU officials. If possible, online qualifying examination and interview can be done; but it this is not feasible, no learner should be barred from admission to the program just because of their failure to have online access to the examination and interview. Other means can be looked into, such as the proficient academic rating of the learner as basis for their admission to the program.

Moreover, schools implementing the program, through the guidance of the Regional and Division Coordinators in SPJ and PSFL, should streamline the curriculum to be offered this school year by reviewing the curriculum guide and determining what should be essentially taught via distance learning. Pending the arrival of the MELCS from DepEd-CO, teachers in SPJ and SPFL should do the following:
