 - iii. If both parents are not available (e.g. deceased, out of the country, missing and cannot be found), only the following individuals can sign the waiver form:
 - a. Grandparent Only if both parents are not available
 - Eldest sibling above 21 years old Only if both parents and both pairs of grandparents are not available
 - c. Actual custodian above 21 years old Only if both parents, both pairs of grandparents, and eldest sibling above 21 years old are not available
 - Photocopy of the student nominee's report card or transcript of records for the current school year 2020-2021
 - Certificate of Good Moral Character of the student nominee
 - Nominators may choose to submit additional documents to support the nomination, such as proof of involvement in extracurricular activities, leadership roles, or community service.
 - Organizers have the right to request for additional documentation to assist them in the nominations screening.

- Place all requirements in a long brown envelope with the student nominee's name and school name on the upper left corner. Submit the duly accomplished BEAR BRAND® BATANG MATIBAY 2021 nomination documents on or before April 2, 2021 by means of mailing or delivery to the respective DepEd Division Offices.
