PREPARATION AND PARTICIPATION TO 2022 PROGRAMME

FOR INTERNATIONAL STUDENT ASSESSMENT MAIN SURVEY

- 1. In adherence to DepEd Order No. 29, s. 2017, "Policy Guidelines on System Assessment in the K to 12 Basic Education Program" and DM-CI-2022-044 entitled "Conduct of PISA 2022 MS National Training and Orientation", the Philippines, particularly **this division**, shall participate in international assessments, one of which is the **2022 Programme for International Student Assessment Main Survey (PISA MS)** for international benchmarking. With its goal of evaluating education systems worldwide, this examination given every 3 years shall test15-year-old students with knowledge and skills along the three cognitive domains: Reading, Mathematics and Science. To represent the Philippines, 188 schools with 42 students each were randomly selected to take the test. One of these sampled schools is **San Miguel Rural Development High School** from San Miguel, Catanduanes. The date of examination is on **April 5**, **2022**.
- 2. To prepare for this test, the following activities shall be done by this office, viz:
 - a. Coordination Meetings. Coordination meetings shall be done by the Testing Personnel to SMRDHS;
 - b. Orientation. An orientation to Learners, Parents and Stakeholders shall be done on March 9, 2022 together with advocacy campaign to ensure support and partnership from parents and stakeholders. This will be spearheaded by the Testing Personnel composed of the following:



- i. Division Testing Coordinator Frankie T. Turalde
- ii. Division IT Officer Jennifer Metica
- iii. Test Administrator Vernie A. Robles
- iv. Division Health Personnel Dr. Kristine G. Santelices
- v. School Head Juan S. Torreja;
- c. Review of Sampled Students. Intensive review shall be done everyday from March 14 to April 4, 2022 except Sundays.
- d. Technical Assistance. Education Program Supervisors in Mathematics, Science and English are tasked to extend technical assistance to the school.
- e. Socio-emotional Sessions. Mr. Vernie T. Robles, Guidance Counselor III of Catanduanes National High School, shall conduct these sessions on March 24-25, 2022.
- f. **Regional Mock Test**. This will be held on March 28-29, 2022.
- g. Other preparations. All other preparations necessary shall be done
- 3. To ensure safety and well-being of everyone, basic health protocols should be observed at all times in all the activities to be conducted relative to this event.
- 4. Service Credits will be granted to teachers who rendered services on Saturdays, in accordance with DepEd Order No. 53, s. 2003 entitled Granting of Vacation Service Credits to Teachers for this specific activity. Likewise, for the non-teaching personnel, granting of Compensatory Overtime Credits (COC) is allowed pursuant to paragraph 5.3, letter K of the Joint Circular No. 2 of the CSC and DBM dated October 4, 2004.
- 5. Travel and other incidental expenses relative to this activity are chargeable to FY 2022 GAAAO/local funds/school MOOE/ all other funds, all are subject to the usual accounting and auditing rules and regulations.
