## SCREENING AND SELECTION OF POTENTIAL LEARNING RESOURCE EVALUATORS (LRE)

TO: Chiefs, CID and SGOD

Education Program Supervisors

Public Schools District Supervisors

Elementary and Secondary School Heads

- 1. In compliance to Memorandum BLR 2024-06-1065, RE: Screening and Selection of Potential Learning Resource Evaluators for School 2024-2025, all interested School Principals, Assistant School Principals, Head Teachers and other non-teaching personnel are enjoined to apply or submit documents as proofs of the following qualifications as reiterated:
  - a. Bachelor's Degree,
  - b. With at least 5 years of teaching experience in the learning area being applied as LRE,
  - c. Has at least 24 hours of relevant training on the development and evaluation of LRs, and
  - d. Not an author, either, or consultant of any commerciallydeveloped LRs submitted to DepED for procurement in the last 3 years from the date of the application.
- 2. It is likewise reiterated that potential LRE must be physically fit, willing and able to travel and participate in the series of content evaluation workshops at a venue which may not be near the province.
- 3. Pursuant to the rationalization of teacher's workload per DepEd Order No. 005, s. 2024, potential LREs must be limited to non-teaching personnel.
- 4. Education Program Supervisors shall be included in the database of potential LREs subject to capability building of BLR. They are also requested to assist the Division Screening and Selection Committee to ensure that

all the following learning areas are assigned with at least five (5) potential LREs:
