UPDATES, CONDUCT OF THE NATIONAL LEARNING CAMP (NLC) POST

1. In line with the **MATATAG: Bansang Makabata, Batang Makabansa agenda**, the Department of Education has institutionalized the implementation of the National Learning Camp (NLC) pursuant to DepEd Order No. 14, s. 2023 and laid down its Learning Recovery Strategies through DepEd Order No. 13, s. 2023 specifically, the 'Adoption of the National Learning Recovery Program in the Department of Education' which aims to strengthen the learning recovery and continuity program, improve literacy and numeracy, and accelerate the achievement of the education targets. Anent to this, the National Learning Camp Post Assessment shall be administered among the learners who took the pre test in the secondary schools nationwide starting August 31, 2023.
2. In addition, DM No. 49, s. 2023 titled 'Administration of the 2023 Special Philippine Educational Placement Test (PEPT) reiterates the submission of required documents of the prospective test takers. The purpose of the said assessment is to allow the learners to access or resume schooling/ and or obtain certification of completion by grade level in the DepEd formal system.
3. Moreover, RA 11476 otherwise known as 'An Act Institutionalizing Good Manners and Right Conduct and Values Education in the K to 12 Curriculum, Appropriating Funds Therefor, and for other Purposes which is the legal basis of the policies of the aforesaid learning areas in the MATATAG Curriculum which both intend to inculcate virtues that are necessary in ensuring the 'intelligence of the mind and maturity of the heart' among learners.
