## ROLL OUT OF THE COMPREHENSIVE SEXUALITY EDUCATION (CSE) INTEGRATION IN THE K TO 12 BASIC EDUCATION CURRICULUM

- 1. Cognizant to DepEd Order No. 031, s. 2018 re: *Policy Guidelines on the Implementation of the Comprehensive Sexuality Education (CSE)*, and as an offshoot of the regional virtual orientation on CSE integration in the K to 12 BEC participated by Division CSE Coordinators, all concerned are hereby ordered by this Office to roll out CSE integration in the K to 12 Curriculum, from the SDO level cascaded down to the School level, to be implemented this School Year 2022-2023.
- 2. The roll out of the CSE orientation aims to inform the target participants about the Comprehensive Sexuality Education Curriculum and the use of evidence-based pedagogies. Specifically, they are expected to:
  - a. discuss the rationale, legal bases and highlights of the policy guidelines of the Comprehensive Sexuality Education (CSE);
  - identify the entry points of the CSE standards in the competencies of Kinder, Araling Panlipunan, Science, Edukasyon sa Pagpapakatao, MAPEH and Personal Development;
  - c. experience the different teaching and learning resources for CSE orientation sessions:
  - d. prepare a district and school CSE action plan as an output of the activity.
