REGIONAL WORKSHOP FOR THE CONTEXTUALIZATION OF MULTI-FACTORED ASSESSMENT TOOL (MFAT) AND FORMULATION OF IMPLEMENTING GUIDELINES FOR ITS REGION-WIDE ADMINISTRATION

To : Schools Division Superintendents

- 1. Assessment plays a crucial role in providing appropriate educational programs and services for learners with disabilities. This premise is highlighted in DepEd Order No. 29, s. 2018, Policy on the Implementation of Multi-Factored Assessment Tool (MFAT); and more recently in DepEd Order No. 2022, Child Find Policy for Learners with Disabilities Towards Inclusive Education. Both issuances consider the significance of a screening tool that gathers information about the learner's strengths, needs, learning styles, and other educational concerns; and assists teachers in the instructional planning and educational placement of learners.
- 2. Relevant to this, the Department of Education, Regional Office V, through the Curriculum and Learning Management Division, will initiate the conduct of the Regional Workshop for the Contextualization of Multi-Factored Assessment Tool (MFAT) and Formulation of Implementing Guidelines for its Region-Wide Administration on **September 23-25**, **2024** in a venue to be announced later.
- 3. During the workshop, the following are expected to be accomplished:
 - a. contextualization of the items in the MFAT;
 - b. formulation of simplified scripts for test administration;
 - c. formulation of the implementing guidelines for MFAT administration,
 - d. finalization of the SNED Framework for Region V.
- 4. Expected to attend this three-day live-in workshop are the following:
 - division SNED coordinators (1 coordinator per division)
 - Special Needs Education teachers (3 SNED teachers per division)
 who have expansive knowledge in the administration of Multi Factored Assessment Tool for Grade 1 Learners
 - 3 CLMD (1 regional SNED coordinator and 2 working staff)
 - 55 total number of participants
- 5. All the participants are expected to arrive at the venue in the afternoon of September 22, 2024, and leave in the afternoon of September 25, 2024. First meal
