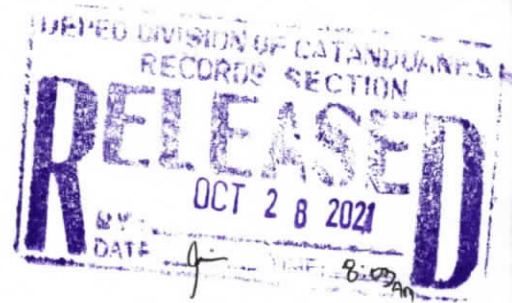

1. This office through the Curriculum Implementation Division (CID) shall conduct the **Division Virtual Orientation on DepEd Order No. 40, s. 2021 entitled " Guidelines for the Implementation of Joint Delivery Voucher Program for Senior High School Technical-Vocational-Livelihood Specializations (JDVP-TVL) for School Year 2020-2021"** on November 3, 2021, at 1:00 PM – 5:00 PM.
