- 1. The implementation of the 8 Week Learning Recovery Curriculum among Grades 1 to 3 learners in Region V is meant to address learning loss and close the gap from current skills to expected literacy and numeracy skills that would help early grade learners progress better. Expectedly after Week 8 of the Implementation of the Learning Recovery Curriculum, assessment activities shall be conducted in all elementary schools to know the gaps were indeed bridged.
- 2. In connection to Regional Memorandum No.127 s. 2022 re: Guidelines on the 8 Week Learning Recovery Curriculum Post Implementation Assessment Activities, there will be a District Orientation on the Administration of the 8 Week Learning Recovery Curriculum Post Assessment to Grades 1 3 teachers and Elementary School Heads on October 21, 2022.
- 3. The orientation aims to assist district in the efficient implementation of post assessment activities to:
 - determine how well the students have performed in the intervention;
 - gather information on how far the actual skills of the pupils with the expected skills for the grade level had been achieved; and
 - record and report the progress of the pupils to inform further instruction.
