HOLDING OF BSP SCHOOL/DISTRICT-BASED CAMPORAL IN ALL ELEMENTARY AND SECONDARY SCHOOLS

- 1. Pursuant to the Boy Scouts of the Philippines, Catanduanes Council Memorandum Circular No. 06, s. 2022, this office announces the holding of a three-day **SCHOOL/DISTRICT-BASED CAMPORAL** in every elementary and secondary schools, this Schools Division Office within the months of November 2022 to January 2023 with the theme "Sustaining Growth".
- 2. The holding of the said activity, should start in the afternoon of Friday and ends in the afternoon of Sunday.
- 3. Commissioners of all ranks and scout leaders should exert rigorous efforts in campaigning for maximum participation in this activity in order for every Boy Scout in the province to benefit from the Scouting Program they rightfully deserve.
- 4. This activity aims to:
 - a. provide outdoor challenges and expeditions necessary to broaden and deepen one's knowledge and skills which are necessary ingredients in person's physical and mental advancement;
 - to participate in meaningful activities that will develop in them a progressive manner, desirable leadership skills and deepen the Scout concern for the upliftment of citizenship training and character;
- 5. Scout uniform speaks well of unity and discipline. Scout leaders therefore should wear their BSP uniform properly in order to encourage and project an image of a scout in uniform.



- 6. It is the responsibility of every Scout Leader to enlighten the community on the philosophy, mission, and objectives of the movement, it is likewise incumbent upon the commissioners and scout leaders to draw the active involvement and participation of their respective barangay officials and other community leaders especially in the planning as well as in the implementation of the Scouting Program in the school.
- 7. It is imperative that an organizational committee composed of commissioners and Scouters as well as the community officials, be informed to plan interesting and challenging advancement oriented Scouting activities.
- 8. A well -organized program of activities will ensure the success of every school/district camporal. Activities planned for the month-long scouting observation should be designed to underscore the enduring ideals of the Scouting Movement. These activities must also project an image that should draw the continuing support of the community. Alternate activities however, may be considered to suit the particular needs in the respective locality.
- 9. To ensure success of the School/District-Based Camporal, all concerned are advised to kindly exert rigorous efforts in the recruitment of scout membership for this school year.
- 10. The authorized membership fees but voluntary in nature per DepEd Order No. 76, s. 2012 are as follows:

a. Scouts - Php 50.00 b. Unit Leaders - Php 60.00

c. Institutional Representatives /
Coordinators/Committee Members - Php 100.00

- 11. After action reports preferably with pictures should be submitted to this office fifteen (15) days after the conduct of this activity.
- 12. Two (2) days service credit (SC) will be granted to teachers who will render services on Saturday and Sunday in accordance with DepEd Order No. 53, s. 2003, entitled Granting of Vacation Service Credits to Teachers. On the other hand, a compensatory overtime credit (COC) will be granted to school heads and other non-teaching personnel per CSC and DBM Joint Circular No. 2, s. 2004 and DepEd Order No. 76, s. 2012.
- 13. The following issuances are hereby reiterated for the effective conduct of this activity:

DepEd Order No. 76, s. 2012, DepEd supports the Revitalization of Boy Scouting in Schools Nationwide.

DepEd Order No. 68, s. 2023, provides guidelines on Revitalizing the Boy/Girl Scouting Movement in Schools.

14. Expenses relative to the conduct of this activity may be charged against School's MOOE subject to the usual accounting and auditing rules and regulations.
