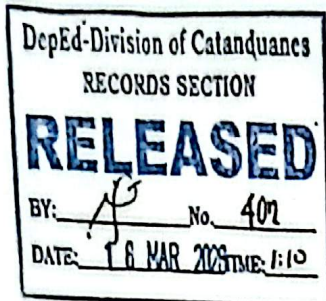

**PROGRESS MONITORING ON THE CONDUCT OF THE NATIONAL ASSESSMENT
FOR SCHOOL HEADS (NASH) PROFESSIONAL DEVELOPMENT (PDI)**

1. In reference to Division Memorandum No. 402, s. 2026, titled *Guidelines on the Conduct of the National Assessment for School Heads (NASH) Professional Development Intervention (PDI)*, this Office, through the Schools Governance Operations Division – Human Resource Development Section, shall conduct Progress Monitoring on the attendance of the identified aspiring principals in relation to the Phase 1 requirements initiated by the NEAP Central Office. The activity shall be conducted in a **face-to-face modality**, as the physical presence of participants is required to signify their commitment through the Coaching Contract. The monitoring will be held **on April 29, 2026**, with the following schedule: **AM (9:00-11:00)**: Aspiring principals who have met the **three domains** of the Philippine Professional Standards for School Heads (PPSSH), **PM (2:00-4:00)** Aspiring principals identified with **developmental areas** requiring further support.
2. Likewise, all participants are required to bring the following during the activity:
 - 2.1. A printed copy of their assessment results
 - 2.2. Their certificate of participation and completion
 - 2.3. Any other available Means of Verification (MOVs) relevant to the program requirements
3. The travel expenses and other incidental expenses of the participants may be charged against the school's MOOE, and subject to the availability of funds and in accordance with existing accounting and auditing rules and accounting.


