- 2. New applicants shall submit to the Schools Division Office a written application supported by the following documents:
  - a. CSC Form 212 (Revised 2005) in two copies with the latest 2x2 ID picture
  - b. Capitified photocopy of PRC professional identification card or a PRC certification showing the teacher's name, LET rating, and other information recorded in the PRC Office
  - c. Certified photocopy of ratings obtained in the License Examination for Teachers/Professional Board **Examination for Teachers**
  - d. Certified copy of transcript of records
  - e. Copies of service records, performance rating, and school clearance for those with teaching experience. If unavailable, the applicant must submit a justification citing the reason/s for unavailability
  - Cetificates of specialiaed trainings, if any

- g. Certified copy of the Voter's ID and/or any proof of residency deemed acceptable by the Screening Committee
- h. NBI Clearance
- i. Omnibus certification of authenticity and veracity of all documents submitted, signed by the applicant
- 3. All teacher-applicants shall take the English Proficiency Test. Previously-ranked teacher applicants who had already taken their EPT may decide whether or not to take the test.
- 4. The cut-off score for inclusion in the RQA is seventy (70) points:
- 5. The members of the Division Selection Committee shall strictly observe the guidelines stipulated in DepED Order No. 22, s. 2015 for this particular selection and evaluation.
