

We appreciate your continued support and look forward to your agency's participation.

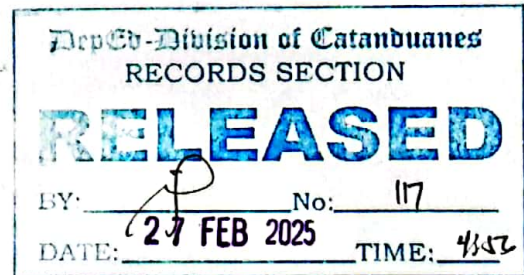
