The DepEd, Division of Catanduanes, through its Bids and Awards Committee (BAC) now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected or purchased at DepEd, Division Of Catanduanes, BAC Secretariat, upon payment in cash of a non-refundable fee by interested bidders in the amount of Five Thousand Pesos (Php5,000.00) per cluster to SDO, Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids.(ITB 6.8)
