**INVITATION TO BID FOR  
CY 2021 HAULING/DELIVERY OF SCHOOL FURNITURE FOR THE  
DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OF  
CATANDUANES (RE-BID)**

1. The *DepEd, Schools Division Office of Catanduanes*, through the *General Appropriation Act (GAA) CY 2021* intends to apply the sum of *Two million eight hundred forty-nine thousand one hundred fifty-six and 51/100 (P2,849,156.51)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CY 2021 Hauling/Delivery of School Furniture (Goods and Services 2024-01)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DepEd, Schools Division Office of Catanduanes* now invites bids for the above Procurement Project. Delivery of the Goods is required by *60 calendar days*. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *DepEd, Schools Division Office of Catanduanes* and inspect the Bidding Documents at the address given below during *Mondays to Fridays 8:00AM to 5:00PM except during holidays*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *June 24-July 15, 2024* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines*

issued by the GPPB, in the amount of **Five Thousand Pesos only (PhP5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The **DepEd, Schools Division Office of Catanduanes** will hold a Pre-Bid Conference<sup>1</sup> on **July 2, 2024 9:00 AM at DepEd, Schools Division Office of Catanduanes Lobby** and/or through video conferencing or webcasting via **<https://bit.ly/CY2021HaulingSchoolFurniture>**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **July 15, 2024 8:30AM**. **Late bids shall not be accepted.**
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **July 15, 2024 9:00AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. *Prior to Bid-Opening, representative of bidders should present and submit to the BAC a **Special Power of Attorney** stating the detailed activities which he/she will perform relative to the bidding at hand and a **Letter of Intent**.*
11. The **DepEd, Schools Division Office of Catanduanes** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
