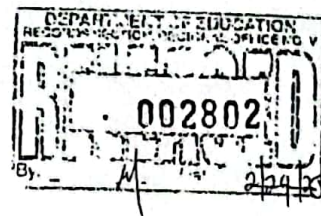

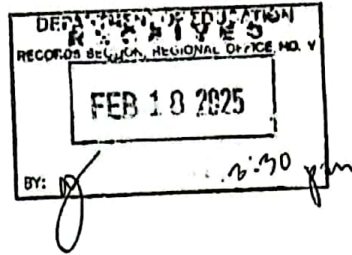

Greetings from the Philippine Statistics Authority (PSA)!

PSA, in partnership with its concessionaire, Unisys Managed Services Corporation (UMSC), has launched the PSA Mobile Civil Registry System (CRS) Outlet across various regions nationwide. This initiative aims to make civil registration services more accessible to the public.

The PSA Mobile CRS Outlet is designed to provide document request services in temporary locations, such as job or school fairs, government caravans, trade fairs, and more. It allows for the on-site issuance of requested documents, including copies of birth, marriage, and death certificates, as well as applications for the Certificate of No Marriage (CENOMAR), Certificate of Marriage (CEMAR), and Certificate of No Death (CENODEATH) record.

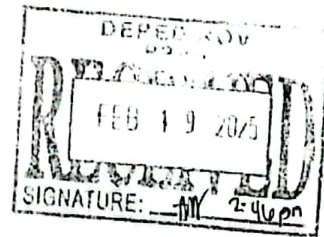
