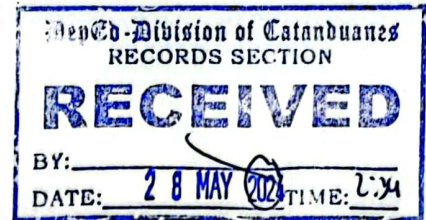





- Any other integrated applications or services that rely on the LIS database infrastructure will also be affected, such as:
 - Basic Education Information System (BEIS)
 - National Building Inventory System (NSBI)
 - Wash in Schools Online Monitoring System (WINS OMS)
 - National Assessment Test Integration System
 - API services of LIS

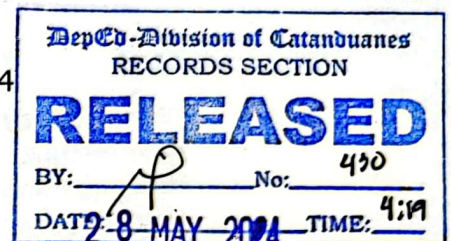
