- 1. This is to inform the participants of the following addendum and corrigendum to Division Memorandum No. 176, s. 2023 re: 2023 Division Secondary Schools Press Conference (DSSPC) viz;
- a. Since TV Broadcasting is a first-time event to be held in the Division, it will be an exhibition event featuring SAVS and PSAT. Schools who will do the exhibition of the said event will be awarded with medals and certificates but they will not acquire points since it is just an exhibition.
- b. Due to Regional call up of the EPS in charge of the DSSPC, the submission of the documents for the Search for Outstanding School Paper Adviser and Campus Journalist is extended from May 23 to its final date on **May 25, 2023**.
- c. Zonal representatives are enjoined to coordinate closely to the 2023 DSSPC billeting committee for room assignment, the process of payment of the registration and membership to the concerned cashier/officer before the actual dates of the 2023 DSSPC. Official delegates shall be registered before the activity to avoid disruptions on the flow of the activities.
- d. School Paper in PDF Form will be submitted to the DASSPA President, in his email address, he will screenshot the actual date and time when the participating schools submitted their school paper entries for verification purposes.
- e. In Photojournalism, maximum of 24 megapixels' point-and-shoot camera, emptied SD Card, extension wire can be used by the photojournalists. Digital Single-Lens Reflex Camera (DSLR) is not permitted.

Reminders for Group Events (Collaborative Desktop Publishing and Online Publishing)

- 1. Laptops, flashdrives, and memory cards to be used during the group contests must be checked by the facilitators on May 25 (Thursday) 8:00 AM-5:00 PM at Calatagan High School. This is to ensure that there are no documents, images, graphics, and media files saved in the devices prior to contest schedule.
- 2. Laptops, flashdrives, and memory cards that did not undergo inspection and checking prior to contest schedule won't be allowed inside the contest room.
- 3. In case the laptops to be used in the contest are borrowed from the school or an individual, coaches must ensure that original files in their contestant's laptop are already backed up in a separate storage. Facilitator's task should only be checking of these devices and NOT emptying of files.
- 4. Installation of software and programs is NOT part of facilitator's task. Coaches and advisers must ensure that necessary programs or software are already installed in the laptops prior to contest schedule (*refer to DO No. 176 s. 2023*).
- 5. For Collaborative Desktop Publishing, the software to be used is Adobe InDesign CS6 version or any high.
- 6. For Online Publishing, the platform to be used is Google Suites platform. Online Pub teams are NOT allowed to use any flashdrive.
- 7. Laptops, flashdrives, and memory cards that already underwent inspection will be put inside a designated room at Calatagan HS. These devices will be released to contestants once the group event has officially started.
- 8. Teams are advised to provide their own extension wire to be used during the contest.
