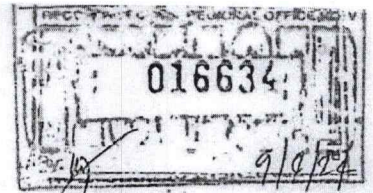

PASSERS IN THE BICOL REGION

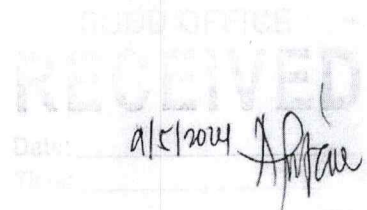

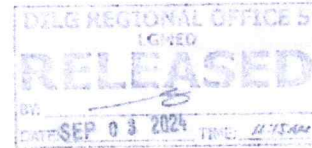
