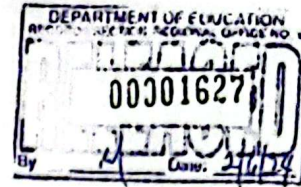

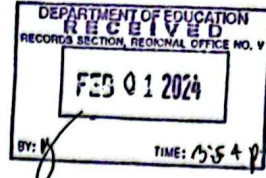

DATE : February 1, 2024

Pursuant to DepEd Order No. 001, s. 2020, otherwise known as "Guidelines for NEAP Recognition of Professional Development (PD) Programs and Courses for Teachers and School Leaders", all NEAP-recognized professional development (PD) programs and courses shall have validity coterminous with the three-year professional development priorities as provided for under DepEd Order No. 50, s. 2020 titled **DepEd Professional Development Priorities for Teachers and School Leaders for School Year 2020-2023**.

With the expiration of DepEd Memorandum No. 050 s. 2020, the field is now advised that the validity of all NEAP-recognized PD programs and courses given by Authorized Learning Service Providers **has expired effective January 2024**.

PD program service providers external to DepEd may continue to offer PD programs subject to the voluntary participation of teachers and school leaders. DepEd shall no longer make endorsements or issue advisory as stipulated in DepEd Memorandum No. 044, s. 2023, titled Interim Guidelines for the Quality Assurance and Monitoring Evaluation of NEAP Core Programs.
