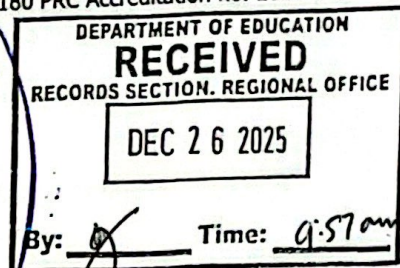
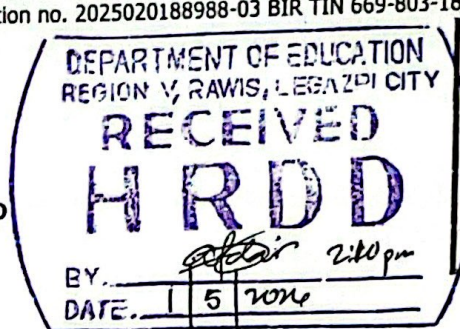
Season's greetings!
