#### **DIVISION MTB ORATORICAL CONTEST**

- 1. In support with the upcoming celebration of the Catanduanes Festival and in order to boost our sense of nationalism through the Mother-Tongue Based-Multilingual Education (MTB-MLE), this office shall hold a Division MTB Oratorical Contest on *October 25*, 2013, in a venue to be announced later.
- 2. The theme of the Oratorical Contest shall focus on "The Catandunganon: Transforming the Present, Creating the Future".
- 3. There will be two categories;
  - A. Elementary
  - B. Secondary
- 4. Participants to this contest are the elementary and secondary students regardless of grade or year level. They should be the 1st place winners of Zonal elimination as stipulated in enclosure 1.
- 5. Oratorical piece shall be delivered in the local/mother tongue language, (e.g. Virac, Panganiban, Bagamanoc, etc.) with attached translation in Tagalog or English language to be distributed to the judges.
- 6. Attached is the zonal distribution of contestants in elementary and secondary and Coordinators. The venue shall be agreed by school heads concerned lead by the Coordinators. Zonal elimination date shall be on **September 30, 2013**. The list of winners shall be submitted to this Office, attn: Dr. Gina B. Pantino, EPS I (English), Division MTB-MLE Coordinator on or before **October 4, 2013**.
- 7. Top three winners will be awarded with Certificates of Commendation and cash prizes during Division/Provincial Finals viz;

- 8. For guidance and references, guidelines/criteria of the Oratorical Contest is also attached.
- 9. No Registration shall be collected, however travel and other incidental expenses of the participants and coaches shall be charged to school MOOE subject to accounting and auditing rules and regulations.

### CONTEST GUIDELINES IN DIVISION MTB ORATORICAL CONTEST

## General Guidelines

- 1. Each Zone shall have one entry for the oratorical contest.
- 2. Drawing of lots shall be done before the contest proper.
- 3. Attire of the participants shall be in the local costume.
  - 4. The decision of the Board of Judges is final.

### **Oratorical Contest**

- 1. Each Zone shall have one contestant.
- 2. Oratorical piece shall be delivered in Mother Tongue/Local language centered on the theme of the activity.
- 3. Delivery time is seven minutes.
- 4. Every five second excess in time is equivalent to one point deduction from the total rating of the contestant.
- 5. Criteria for judging include:

a.	Content/substance	-	40%
b.	Mastery		30%
c.	Delivery	_	20%
d.	Audience Impact	-	10%
